Grant Received:

I Received an Eli Lilly humanities research grant through Taylor University to study Mormonism during the summer of 2006, and another grant to do follow-up work during the summer of 2008. I spent time in Utah (and elsewhere) interviewing Mormons, ex-Mormons, and Evangelicals about why they believe that their faith is true. The result was a book that organizes and analyzes the answers and provides commentary on why people believe. It also suggests what the role of religious experience, reason, and social context ought to be in the debates surrounding religious truth claims. During the summer of 2012 I received funding from the Department of Philosophy and Religious Studies at Central Washington University to do follow-up research in Utah, leading to the creation of a new course on Mormonism.
